In some cases, an unemployment official will interview you to clarify and verify details regarding your case and your identity. If you want to make sure your claim isn't delayed, be sure to complete all the sections fully and accurately. When you file your claim, you will be asked for some personal information, including your name, address(es), social security number (SSN), last 18 months of employment history, a record of wages earned and the reason and dates for your employment termination.
